PRESENTING CLINICAL SIGNS

P presented on 4/29 9:30am. P started acting differently yesterday. Has been losing weight and slowing down, will go off a lay alone, not eating since yesterday, labored breathing and swollen RF leg

Abnormal PE/Chem/CBC/UA Results: CBC HCT 31 (37-61), WBC 24 (5-16), Neu 20 (2.9-11), PLT 112 (148-484) Chem TP 4.1 (5.2-8.2), ALB 1.5 (2.3-4), Tbil 1.2 (0-0.9)

LIMITED ULTRASONOGRAPHIC EXAMINATION OF THE ABDOMEN

Rapid view of the abdomen revealed multiple disruptive mixed hypoechoic masses with irregular contour.

Regional abdominal free fluid and target type lesions were noted.

Enhanced surrounding mesentery and multiple enlarged hypoechoic irregular lymph nodes were present with peripheral inflammation.

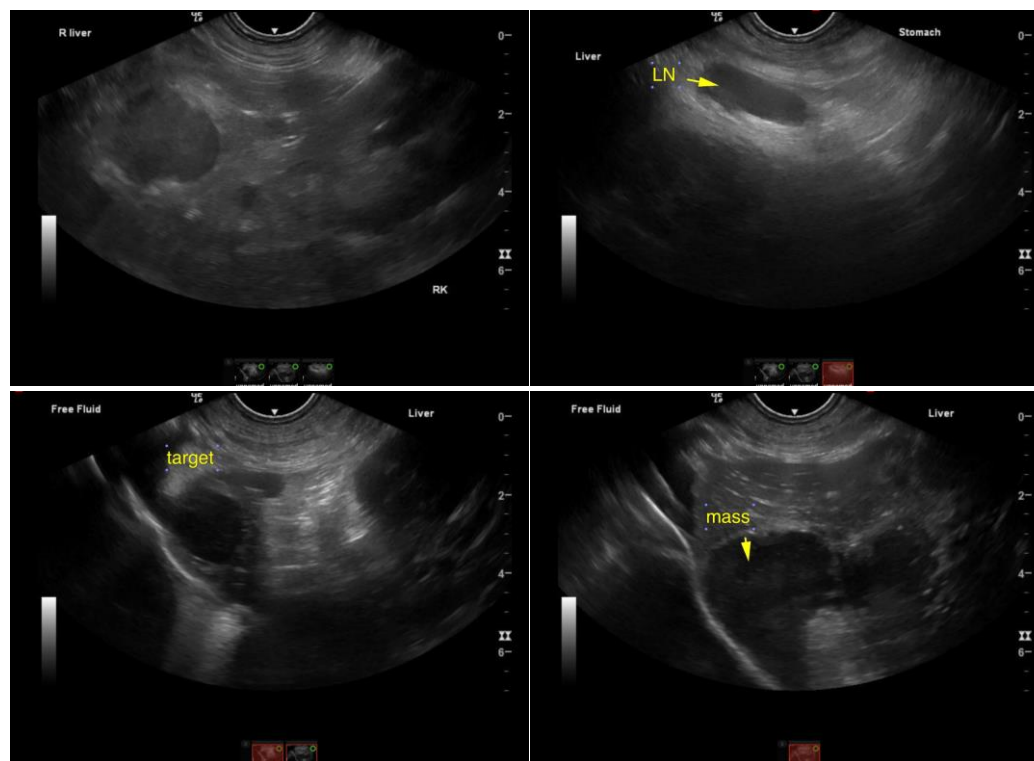
Free fluid was noted in the chest, likely owing to metastatic disease.

ULTRASONOGRAPHIC FINDINGS

- Multifocal lymphoproliferative pattern involving lymph nodes, liver and thorax.

INTERPRETATION OF THE FINDINGS & FURTHER RECOMMENDATIONS

Multicentric round cell neoplasia such as histiocytic sarcoma or lymphoma is likely.
